**MEDICAL REPORT
(SHORTENED VERSION, PRELIMINARY)**

Dear Mr. Fox:

I hereby send to you the shortened and preliminary version of the medical report (The treatment and testing is still in progress.) regarding your treatment in my clinic for submission to local officials, physicians and health authorities.

- Diagnoses:**
- Severe chronic contamination and physical toxic poisoning (technical Lindane, Uranium, Dioxins, DDT and DDE and others)
 - Multiple Chemical Sensitivity Syndrome (MCS)
 - Combined restrictive and obstructive pulmonary ventilation disorder (lungfunction)

Diagnoses:

- Toxicodermatitis (preferentially at the lower extremities and feet)
- Toxic allergic reaction (IgE ↑)
- Polyneuropathy / polyneural oradiculitis (caused most likely by chronic contamination and physical intoxication with technical Lindane and other toxic poisons)
- Pantropic virus disease (suspicion on Slow Virus Disease, CJD / BSE?)
- Toxic hepatopathy
- Cholecystitis, Cholecystalgia
- Condition after papillotomy (March 1997 in The Middlesex Hospital ?)
- Chronic nephritis
- Chronic intoxication with heavy metals (Cadmium, Nickel, Lead, Mercury)
- Odontogenous fields of disturbance
- Reactive depression

Medical statement:

This 47 year old patient was referred to my clinic for investigation and treatment of the causes of his multiplicity of symptoms and his bad health condition and he is under my medical care and medical treatment since October 1997.

The medical history is several years long and consists of various continuous severe symptoms with dull ache in the right upper quadrant with occasional severe exacerbation which radiates down to the groin and testicle and down to the right knee.

He also suffers from severe cholangiolitic pains radiating into the back and into the right abdomen superimposed by kidney pains.

Mr. Fox suffers from a dermatitis preferentially at the lower extremities and feet but also at the other extremities as well with severe bullous desquamation of the skin in layers of 1 to 2 mm thick with occasional severe exacerbation especially at the bottom of the feet and interdigital.

He also suffers from paraesthesia with ache at different dermatoms especially at the right cranium and upper extremities and as well from attacks of severest head aches

This is accompanied by reactive depressive episodes with mood swings and agitation.

This symptoms have been documented and the underlying causes of the diseases and symptoms found and proven clinically, chemically, with computer segmental electrography and all kinds of standard investigative medical methodology.

According to his reports and the evidences shown to me the toxic source for some of the most toxic poisons comes with great likelihood from the land around his house and the surrounding area. The contamination seems to have migrated off of the adjacent site into his land.

I have done exhaustive clinical and biochemical examinations and investigations which are still in progress and obtained test results which show a very severe and serious physical condition of Mr. Raymond James Fox with a definite toxic allergic reaction from technical Lindane, Uranium, Dioxins, DDT and DDE and possibly others yet not identified toxic substances or viruses.

I am heavily concerned about the clinical and chemical evidences of a severe toxic poisoning of Mr. Raymond James Fox which have caused a severe health damage and endangered his life.

This demands very strongly that he under no circumstances should return to his house and land and live there for the time being as this would threaten his health and endanger his life.

This also is valid for his wife and his two children. His family as well under no circumstances should return to their house and land for the time being as this would threaten their health and endanger their life, too.

Because of the severe and serious condition and endangerment not only of Mr. Raymond James Fox and his family as well as other people living in the surrounding area I have the obligation to notify this to accountable English authorities for this area.

I have painstakingly taken every effort to get the virus or poison detected and proven. I have carried out exhaustive clinical and biochemical examinations and investigations which are still in progress and obtained test results which show a very serious physical condition of Mr. Raymond James Fox with a definite toxic allergic reaction resulting from a mixture of toxic substances in the body of Mr. Fox of which we have chemically proven above limit values: technical Lindane, Uranium, Dioxins, DDT and DDE and possibly will prove as well others yet not identified toxic substance or virus which have not yet been found.

When we have the full results I shall write the final medical report and send a copy of this to you and the British medical authorities which are concerned and are involved.

A stringent therapy with antitoxic medications, high dosage vitamin, special sera, electrolytes and trace elements infusions, antidotes as well as blood cleansing has extensively been administered to stabilize and improve the health condition of Mr. Fox.

From the kinetics of the elimination rates of this poison we have to assume that he was exposed to a very high concentration of technical Lindane, Dioxins and Uranium, at least in the area where he lives, for a long time so that all other people living in this area are endangered and this demands immediate actions to prove the contamination and then decontaminate the land around his house and the surrounding area.

I am now further more concerned about Mr. Foxen's wife and children I have to stress very severely now that they have to be removed from the area where they live immediately to a non poisoning area.

My findings are conclusively supported by the report of Dr. Robert Cass from the USA and his findings who examined Mr. Fox in the UK and advised him to obtain immediate medical help just before his admission to my clinic.

I have to demand and insist on that my patient Mr. Raymond James Fox has to be protected from any further stress so that his recovery is not thwarted.

It is very astounding that after all the damage Mr. Fox has encountered and after he has been poisoned that still no action is taken at the accountable side to investigate and stop this and support Mr. Fox so that after all this he has not in addition to bear everything and fight entirely on his own.

The clinical and biochemical examinations and investigations are still in progress but the results we so far have obtained show nevertheless a very serious physical condition of Mr. Raymond James Fox resulting from a definite toxic reaction on contamination with technical Lindane and its isomers and metabolites, **Dioxins, Uranium** and also DDT and DDE in a high concentration and possibly from a yet not identified toxic substance or virus (BSE or CJD) which we have not yet tested for because of the extreme high expenses and costs for testing this in a toxicological lab.

I am allowing Mr. Fox to stay at home in the UK for the next month on the strict premise that he does not stay at his home as the toxic source does with great likelihood really come from the land around his house and the surrounding area and the contamination has migrated off of the adjacent site into his land. This is evidently supported by the fact that when he goes to the affected area he becomes very ill for 3 to 5 days with the same symptoms as with a acute intoxication with Lindane (γ -HCH) and this correlates precisely with the elimination rate of Lindane, too.

As we have found Lindane, it's isomers and it's metabolites in the blood, urine as well as in fatty tissue and in the bile and in the skin in a high concentration it is very obvious that Mr. Fox must have been exposed to a even much higher and very toxic concentration of a mixture of technical Lindane, before he was treated.

And there may be not a safe level of exposure to a carcinogen like Lindane, so all contact must be reduced to the lowest possible level.

I am not prepared to jeopardize Mr. Foxen's life any further and I also am concerned for his wife and his children who must be moved out of this area immediately.

One thing which definitely we should not do and which makes no sense at all is to argue about the level of concentration of Lindane in the body of the patient because: there are no normal values at all. And it is scientifically known that even the lowest concentration of such a substance can cause severe chronic

conditions. But in the case of Mr. Fox we have found quite alarming levels of concentration in the body.

It now is inevitable and mandatory to examine Ms. Fox and her children and test for Lindane, too, so it can explain this very dangerous illness Mr. Fox has acquired from his residential home.

As long as this mandatory step has not yet been done it is advisable to seal off the ground to ensure that no other person acquires this dangerous ill.

As the health damage of Mr. Fox could be the matter of an evil-doer nature of toxic poisoning we might be obliged to report this to EC authorities if the accountable national authorities are not in the position to handle this matter and do something for Mr. Fox and his family as well as for the other people endangered.

He is suffering from a chronic poisoning and he is in the treatment phase of a detoxification of a long acting exposition to technical Lindane and it's isomers, Uranium, Dioxins, DDT, DDE and other toxic substances. There can occur a different kinetics of mobilization of the deposits so that even very low concentrations of this substances can aggravate his clinical symptoms and cause a severe reaction of the body and can cause a relapse of the patient.

Because of his serious health condition he is not allowed to work or being burdened with any stress of any kind for at least the next 6 months.
