#### AFFIDAVIT OF JONATHAN CHARLES COBBOLD

- I JONATHAN CHARLES COBBOLD Solicitor a partner in Messrs Gross & Co Solicitors of 84 Guildhall Street, Bury St. Edmunds, Suffolk MAKE OATH and say as follows:-
- On 13th April 1995 I attended a meeting at my above offices, to act as an independent observer in connection with the opening of replies to a Shell Retailer Survey undertaken by the Shell Corporate Conscience Pressure Group.
- Those present when the envelopes were opened and the results collated were myself and John Alfred Donovan ("Mr. Donovan"), of the Shell Corporate Conscience Pressure Group.
- 3. Prior to 13th April 1995, my firm had not acted for Mr. Donovan in his personal capacity. In addition, I had never met Mr. Donovan prior to the 13th April 1995. My firm had on the 23rd March 1995 previously acted as an independent observer in a similar transaction for the Shell Corporate Conscience Pressure Group.
- 4. The envelopes I was to observe opening contained completed response forms in the same form as that now produced to me and marked "JCC1". The envelopes were all opened in front of me and were stapled to the respective response form.

  These were then handed to me for verification.
- I confirmed that each response had been completed correctly and checked the postmark on the envelope against the address of the particular respondent; there were only six postmarks that I was unable to read.
- 6. Following such verification I placed each form in three

corresponding piles according to the box that had been ticked by the respondent, making a note of whether the response was yes or no.

- 7. The forms were all counted by me.
- 8. On 20th April 1995 Mr. Donovan attended at my firm's offices at 84 Guildhall Street, Bury St. Edmunds, Suffolk with a further four envelopes.
- 9. These further envelopes were opened and checked in the same manner as before.
- 10. The total number of responses was 102, of which 14 were incorrectly completed and were judged by myself as "spoils".
  Of the remaining replies, the responses were as follows:-

first question 10 - yes, 77 - no second question 80 - yes, 8 - no third question 77 - yes, 10 - no.

Dear Sir.

Having recieved the letter from your pressure group today and after my telephone conversation with one of your associates I felt I must write to add our own concerns to that of others you have obviously recieved recently.

We as a company have sold shell petrol at this location for sixty years. The last fifteen of which we acted as both landlord and tennant in respect of our forecourt retailing opperation. And up untill the last five years have had an extremely good and cordial relationship with SHELL UK. However the last five years have seen a drastic change in this relationship. With SHELL UKs apparent policy change from an agressive pricing structure within its retailing operation to one of a non agressive stance and since this inception its savage attitude towards its own retailing network.

It would appear to ourselves that since many of SHELL UKs own staff have left the company(staff I would suggest of long and experianced standing) they appear to have been replaced by what I can only call college boys who would appear to be operating on the text book mentality of business operation to the cost of all else.

With the above in mind as our contract with SHELL UK expired in july of 1994 we were faced with the choice of running our forecourt ourselves as independants or to lease our site and have no more involvement in its daily operations, as we did not want to remove shell petrol from our site we chose to lease the site to shell for a further 15yrs but even this was not straight forward. The fickle nature and lack of honour within our negotiations were a shock to our selves coming from a large company as Shell obviously is. But in retrospect we are now not suprised.

we would hope this letter may help you and serve as a warning to others contemplating any form of activity with this company.
