Dear Mr Fox:

I hereby send to you the medical report regarding the treatment of your son Christopher in my clinic for submission to local physicians.

Diagnoses:

 Severe chronic intestinal ailment with recurrent abdominal pain and subileus

DD: appendicitis, intestinal obstruction, renal cystic disease, leukaemia, psychosomatic origin

Renal cyst, left lower lobe of the kidney, diameter 1,04 cm

DD: autosomal dominant renal cystic disease, yearly renal ultrasound recommended

Copper and Cadmium poisoning, ≥ 5 ppm in the urine

- Urinary tract infection; nitrite pos., protein 100 mg/dl in the urine
- Remarkably reduced index of the alkaline leukocyte phosphatase to 1 (reference value 18-100)
- Moderate spienomegaly

This 12 year old boy was referred to my clinic for investigation and treatment of the causes of his severe chronic intestinal ailment with recurrent abdominal pain.

At submission, the young patient had severe abdominal pain with defence tension, no fever, diarrhoea or vomiting, signs for a urinary tract infection (nitrite pos., protein 100 mg/dl in the urine), no hematuria, c-r protein neg., whole blood cell count normal as well as the sedimentation rate, liver, kidney, electrolytes values normal.

The abdominal ultrasound was without signs for intestinal inflammation, no appendicitis, liver, pancreas normal, moderate spleromegaly, kidney volume normal, kidney texture and achogenity normal, renal cyst, left lower lobe of the kidney, diameter 1,04 cm.

With electrolyte infusions, vitamin infusions, acupuncture and homeopathic remedies Christopher recovered quickly and was clinically and subjectively perfectly well when he left the clinic at the 20th of December 1998.

Recommendations: Yearly renal ultrasound, in case of further abdominal pain, please do a multiple stool check for microbiological examination (parasites, funguses), check for Helicobacter pylori infection, do a psychological check-up.

Nevertheless, because of the remarkably reduced index of the alkaline leukocyte phosphatase to 1 (reference value 18-100) I have to advice and strongly recommend as a further examination a bone marrow biopsy with a histological differentiation and histochemical testing to exclude a chronic damage of the bone marrow and a chemical toxic alteration of Christopher's bone marrow as a result of the chronic contamination and toxic poisoning on your ground and in your house.
