Re: Former Shell UK Depot, Wokingham Road, Earley, Reading

I am writing to advise you that a start will be made within the next two weeks on the redevelopment of the above site

The first operation will be that of site clearance, whereby the existing soil is replaced with clean imported soil. This will be done by means of excavation and disposal via mechanical diggers and tipper lorries. The entire process should take about 3 months, completing some time in September 1998

In the course of these works, it will be the intention at all times to cause you the least possible disruption. For this reason, two companies have been specifically selected for their experience and expertise in dealing with sites of this nature. Shanks & McEwan, one of the country's leading waste management companies, and Kane Haulage, an established company providing a range of specialist services to the civil engineering and construction industries.

Attached is a list of emergency telephone numbers from these 2 companies. These numbers should be used in the event that you have any concerns directly related to the site clearance operation being carried out

At certain times, the excavation process may give rise to certain odours. Our appointed contractors will be monitoring for these odours at the site boundary, but any specific instances of concern should be addressed using the procedure specified above.
